PURPOSE

The purpose of this policy is to promote a safe environment within all our ministries at Castlefields Church and to lay out our expectations of and provide guidance for those who care and protect

- Children and vulnerable adults
- Other attendees
- Staff and volunteers

SCOPE OF POLICY

This policy applies to **everyone at Castlefields Church**, volunteering or paid, working with children, young people and vulnerable adults on behalf of Castlefields Church. This includes any trustees and senior leadership, and anyone else who may come into contact with children, young people or vulnerable adults.

OUR VALUES AND BELIEFS

(this is not a statement of faith)

Our approach to safeguarding is shaped by our Biblical beliefs, in particular:

- Our world is fallen, broken and marred by sin. Hence, we seek to protect everyone, especially those most vulnerable, from the inherent dangers of a fallen world
- Each person in this world bears the image of God, being valuable to Him from conception
- Any sin in our midst won't be tolerated, but dealt with in a Biblical manner, decisively, effectively and transparently
- We obey the law of the land, honouring those God has put in place above us
- We are not a gathering of sinless and perfect people but rather a community of grace where we seek to encourage one another to grow in faith and obedience to God
- We are to love those around us as God loves them and to seek to bring healing, restoration and reconciliation to broken and damaged lives by the manifestation of the love of God through us

OUR SAFEGUARDING RESPONSIBILITIES AND COMMITMENT

Our responsibilities

- Ensure the protection of children, young people and adults at risk of abuse
- To protect these groups of people in light of the Gospel
- To pay attention to the protection and nurturing of those in our midst who are particularly vulnerable to abuse or neglect. This includes ensuring their voice is heard.
- To work in partnership with any agencies and organisations to ensure protection of those who are vulnerable

How we will seek to fulfil these responsibilities

- Actively maintain a positive culture within the church in view of our safeguarding responsibilities before God and the law of the land
- We will seek to visibly demonstrate our commitment to safeguarding throughout the organisation and our most senior leaders will support the development of best practice and provide accountability to everyone who works (whether paid or voluntarily) on our behalf
- Safeguarding will be led by one of our senior leaders from the church leadership (known as the Designated Safeguarding Lead). See Key People (below)
- We will appoint at least one Deputy Safeguarding Lead who will support the Designated Safeguarding Lead in tasks and responsibilities. See Key People (below)
- The church is committed to safer recruitment when selecting volunteers and/or employing workers within the church, as outlined in our Safer Recruitment Policy
- All volunteers and workers will be trained in safeguarding every 3 years and a record of training is to be kept
- Safeguarding leads and deputies will be trained to appropriate levels in order to fulfil their roles and deal with safeguarding competently and confidently
- When identifying any concerns about the safety or wellbeing of an individual, we will respond appropriately and proportionately by signposting or referring to local or national services, as well as offering support as we are able
- To ensure that as a church we are alert to our duties around the Prevent duty 2016 and to report appropriately (see appendix)
- All information, including disclosures, will be recorded in a timely and accurate manner according to our Data Storage Policy and legal duties. This will include records such as consent forms, attendance data, accident and incident reporting and any safeguarding concerns.
- We will ensure that children, young people, their parents/carers and vulnerable adults are aware of our safeguarding practices wherever possible
- We have procedures in place for any disclosures made please see Castlefields Safeguarding Practice Guidelines (Dealing with Disclosures)
- Policies will be reviewed annually
- Our safeguarding policy is publicly available on the website and a copy is kept at the church The Church Leadership is committed to offering pastoral care, working with statutory agencies as appropriate, and support to those attending the church who have been affected by abuse
- If the Church Leadership is made aware of an individual who would like to start attending / is attending Church Sunday services and would present a safeguarding risk to children or vulnerable adults then specific safeguarding measures will be put in place. The Church Leadership will supervise the individual concerned and offer pastoral care but will require the individual to comply with reasonable boundaries, which, if ignored will regrettably mean that the individual will no longer be allowed to attend Church Sunday Services
